

Stacey "Ax" Axmaker Receives SMSA 2013 Outstanding Contribution Award

The 2013 SMSA Outstanding Contribution Award was presented to Stacey "Ax" Axmaker, Idaho *STAR* Program. The SMSA Outstanding Contribution Award recognizes individuals for their dedication, commitment and contribution to motorcycle safety which has had a positive impact on a national, state or local level.

Ax is the Director of the Idaho *STAR* Motorcycle Safety Program. Ax has been teaching rider training for 22 years. His first full-time position was as the 'Mobile Program Coordinator' for the TEAM OREGON Motorcycle Safety Program in 1997. That year, the Mobile Program won a national award from the Motorcycle Safety Foundation and in 1999, TEAM OREGON won the MSF's Outstanding State Program award.

In addition to many other accomplishments, Ax served on the Technical Working Group for the 'National Administrative Standards for Entry-Level Rider Training' project from 2011-2013 sponsored by NHTSA and led Idaho's efforts to update their entry-level rider training curriculum to meet NHTSA's National Curriculum Standards, published in 2011.

In Idaho, motorcycle crashes and fatal motorcycle crashes are on a downward trend. Motorcycle Safety is now a focus area of the transportation department's efforts and decisions. Motorcycle rights groups, law enforcement, rider training, and the office of highway safety all work together on projects to reduce crashes and fatalities involving motorcyclists.

Idaho's data shows that over 70% of fatal motorcycle crashes are associated with rider error. Ax has been successful in helping to shift media efforts at the state level from a strictly 'motorist awareness' focus to reaching the riders themselves with messages regarding alcohol, riding gear, and riding skills.

As a result of many years of effort, much of the local media now is very open to discussing motorcycle safety beyond helmets and helmet laws. They are also willing to report on motorcycle "riding gear" inclusively, rather than just on the helmet.



Ax has been bringing content, new ideas, and value to the SMSA Conferences and Summits since 2002. He has developed curricula and trainings that he has willingly shared across state and national borders. He has successfully partnered with the Motorcycle Riders Foundation (MRF) Awareness and Education to support and augment motorcycle safety as a fixture in the MRF Reports magazine as well as at conferences. Ax talks comfortably with NHTSA and other federal agency officials as well as with ABATE and MRF officers and members. He has demonstrated a path for finding common ground and building coalitions in which people from very different backgrounds can work together toward the common goal of fewer crashes and fatalities involving motorcyclists.

Ax continues to push and encourage our industry to be about motorcycle safety more generally, and not just about rider training. For more visit www.smsa.org/Awards.

Florida Receives the SMSA 2013 Outstanding State Award

The SMSA Outstanding State Award recognizes a state with a comprehensive state motorcycle safety program (NHTSA Highway Safety Program Guideline No. 3 – Motorcycle Safety Program) and has implemented strategies that are successful, effective and can be measured, evaluated and serve as best practices.

The 2013 SMSA Outstanding State Award was presented to the Florida State Safety Office in recognition of its comprehensive state motorcycle safety program for implementing strategies that are successful, effective and can be measured, evaluated and serve as best practices.

SMSA congratulates the Florida State Safety Office for this prestigious award.

Florida Motorcycle Safety Coalition & Comprehensive Motorcycle Safety Program

Over the past decade, motorcycle registrations have more than doubled in the U.S. and a much larger increase has been observed in Florida. The state's sunny weather, beautiful beaches, and scenic highways make it a popular place for motorcycle enthusiasts. The state is also host to popular motorcycle rallies, such as Biketoberfest and Daytona Bike Week. Florida's growing rider population and popularity with motorcycle enthusiasts makes motorcycle safety an important issue. Corresponding with the sharp increase in motorcycle registrations, Florida also had witnessed an increase in motorcyclist fatalities and injuries motorcycle fatalities as part of all traffic fatalities in Florida spiked above 15 percent in 2006. Considering that motorcycles represent less than three percent of all motor vehicle registrations in Florida, fatal motorcycle crashes are a critical safety concern in Florida.

The high level of commitment by Florida's Comprehensive Motorcycle Safety Program to motorcycle safety begins with the Florida's Department of Transportation (FDOT) State Safety Office, which manages Florida's Strategic Highway Safety Plan (SHSP). The SHSP, a data-driven plan that addresses the "4 E's" of safety – engineering. enforcement, education, and emergency response, addresses motorcycle safety issues in the Vulnerable Road Users emphasis area, with a goal of reducing motorcycle fatalities, injuries, and crashes. The program, in an immediate response to the 2008 National Highway Traffic Safety Administration (NHSTA) technical assessment of Florida's motorcycle safety efforts, involved a wide range of safety partners to develop the Florida Motorcycle Strategic Safety Plan (MSSP). The MSSP supplements and expands on the SHSP by providing more detailed objectives and strategies to improve motorcycle safety in Florida.

A detailed business plan to aid in implementing the strategies and action steps set forth in the MSSP was developed, and the Florida Motorcycle Safety Coalition was established, which includes representatives from FDOT, the Florida Department of Highway Safety and Motor Vehicles (DHSMV), the Florida Department of Health (DOH), local agencies, motorcycle clubs/groups, state and local law enforcement, emergency management, motorcycle safety interest groups, and transportation research specialists.

The Florida Motorcycle Safety Coalition is led by a FDOT traffic safety specialist and it performs a vital role to prioritize and implement the strategies and action steps identified in the MSSP business plan to reduce motorcycle-related fatalities, injuries, and crashes in Florida. The Center for Urban Transportation Research (CUTR) at the University of South Florida provides technical and administrative support to the Coalition and assists it with implementing the MSSP. CUTR also oversees the State's motorcycle public information and education efforts, including the development, production, implementation, and dissemination of outreach materials.

Florida's Comprehensive Motorcycle Safety Program far exceeds the definition of a Comprehensive Motorcycle Safety Program in comparison to other state programs. The coordinated efforts between FDOT, the State Safety Office, the Florida Motorcycle Safety Coalition, and CUTR make Florida the leading authority in motorcycle safety with strategies that are successful, measureable, effective, have been evaluated, and can serve as best practices. Florida's efforts and activities have led to a 20 percent reduction in the number of motorcyclists killed in four consecutive annual reductions and a six percent reduction in the number of motorcycle crashes from 2007 to 2011 despite little fluctuation in ridership numbers, no state universal helmet law, and the fact that motorcycle riding is a year-round activity in Florida.







The Florida MSSP identifies goals, strategies, and action steps to implement improvements in the program areas. The eleven program areas are as follows:

- Data and Analysis;
- Program Management and Evaluation;
- Personal Protective Equipment;
- Operator Licensing;
- Rider Education and Training;
- Rider Impairment and Speeding (FDOT added speeding to the Rider Impairment emphasis area due to a great need to address speeding issues)
- Legislation and Regulations;
- Law Enforcement and Emergency Services:
- Roadway Engineering;
- Rider Conspicuity and Motorist Awareness; and
- Communications.
